Meeting started @ 6:01 p.m. Mr. Pacetti opened the meeting and roll call was performed. Let the records indicate a quorum was achieved. Item of Business: Mr. Pedraza submitted replat plan and pictures for review by board. A question was presented about setbacks compliance of the metal building. The metal building does comply to setback requirements for R-2 districts, but an accessory building cannot be located in the front yard setback. Members present were Rodney Pacetti, Chris Crain, Rod Hatch, and Secretary to the Commission Don Pedraza. Meeting started @ 6:08 p.m. Mr. Pacetti opened the meeting and roll call was performed. Let the records indicate a quorum was achieved. Item of Business: The members present for this meeting were also at the Joint Public Hearing. The commissioners knew the only concern was from Mrs. Beaumont. Mr. Pacetti restated the concerns of Mrs. Beaumont; her concern is that the new construction would cause flooding on her property. All agreed the concern was heard and will be handled properly by the developer. 2. Mr. Rod Hatch made a motion to present the replat to City Council for final approval of replat. Mayor Bailey asked for questions or comments. Mayor Pro Tem Theis asked if this is the property on Baird that had been previously discussed. Mr. Sosa stated that was correct and then asked Building Official Don Pedraza why the City would allow someone to do something that is in violation of City code. Mr. Pedraza explained that the property owner is asking for a variance that will be considered by the Zoning Board of Appeals. Motion passed unanimously.

CONSIDER FINAL DENIAL OR APPROVAL OF THE REPLAT OF PART OF LOT 16, BLOCK 6, OF THE COUNTRY CLUB ESTATES AND COUNTRY CLUB ESTATES REPLAT (6444 AND 6448 HOWE): Councilmember Borne moved to consider final denial or approval of the replat of part of Lot 16, Block 6 of the Country Club Estates and Country Club Estates Replat and Councilmember Badon seconded. Councilmember Borne asked if the plans had been submitted for approval to the City and Mr. Pedraza stated that they had. Councilmember Borne reiterated that the drainage will go to the front of the property and that the yards will not be higher than the property adjacent to the new homes (the homes will be higher, but not the yards). Councilmember Borne asked if Mrs. Beaumont was present at the Council meeting and she was not. Councilmember Borne amended his motion to call for approval of the replat and Councilmember Badon seconded the amended motion. Mayor Bailey asked for questions or comments and there were none. As a result, Groves has gained over 500 new homes in the past two years. There were no further comments and Mayor Bailey adjourned the meeting at 5:45 p.m.
